A resolution pursuant to Section 520.1 of the School Code authorizing Administration to take certain actions in connection with the COVID-19 pandemic for the 2021-2022 school year.

The adoption of a revised Phased School Reopening Health and Safety Plan and authorization for submission and posting by Administration, as mandated by the Pennsylvania Department of Education and the Secretary of the Pennsylvania Department of Health.

The election of Diana Heuser as the Lenape Joint Operating Committee Board Secretary for a four-year term expiring on June 30, 2025.

The election of Brady Shafer as the Lenape Joint Operating Committee and Armstrong County Area Vocational-Technical School Board Treasurer for a one-year term expiring on June 30, 2022.

The appointment of Daniel P. Lucovich as the Board's Voting Delegate to the Pennsylvania School Boards Association 2021 Delegate Assembly to be held on October 23, 2021.

An agreement with The Children's Institute of Pittsburgh, for educational services to be provided to two District resident students in an extended school year program, from June 1, 2021, through August 6, 2021, in accordance with the students' IEPs.

An agreement with the Western Pennsylvania School for Blind Children, for educational services to be provided to two District resident students in an extended school year program, from July 12, 2021, through July 30, 2021, in accordance with the students' IEPs.

An agreement with Pittsburgh Behavioral Services, Inc., for educational services to be provided to a District resident student in an extended school year program in accordance with the student's IEP, from June 9, 2021, through September 1, 2021.

An agreement with WestARM Therapy Services, Inc., for occupational and physical therapy services to be provided to students during the 2021-2022 through 2025-2026 school years.

Acceptance of the donation of labor and materials from Kelly Automotive and 84 Lumber for the construction of a storage shed for the use of the Cross Country team, with any remaining costs to be covered by the Cross Country Team Boosters.
