MINUTES OF THE REGULAR MEETING HELD ON MARCH 13, 2019

The regular meeting of the Freeport Area School District Board of School Directors scheduled for 7:30 pm in the Audion of the Freeport Area High School was called to order by Mr. Daniel P. Lucovich, President, at 7:31 p.m.

The Board recited the Pledge of Allegiance to the Flag.

Reports

- 1. It was moved by Mr. Haven, and seconded by Dr. Prazenica, to approve the minutes of the Regular Meeting held on February 13, 2019. Motion carried unanimously.
- 2. Ms. Dobransky reported that the Board met as follows since her last report to the Board at the Regular Meeting on February 13, 2019: The Board met in Executive Session on March 6, 2019, to discuss safety and security, personnel, and contracts and negotiations matters. The Board held its Committee Meeting on March 6, 2019. The Board met in Executive Session on March 13, 2019, to discuss safety and security, personnel, legal, and contracts and negotiations matters.
- 3. Mr Lucovich reported that Lenape Technical School's board would meet the following week. He extended an invitation to everyone in attendance to the open house to be held at Lenape Technical School the following day.
- 4. Mr. Magness and Mr. Robb referred the members to Administration's report provided as an attachment to the agenda.
- 5. Dr. Prazenica reported that the Armstrong Indiana Intermediate Unit (ARIN IU 28) board would meet the following week.

- 6. Ms. Bollinger provided the members with her legislative report: The governor is setting aside \$600,000 in state funds for local schools interested in expanding breakfast programs for hungry kids, which will be available to schools that offer breakfast to all students in the building. The House Judiciary Committee unanimously advanced a bill Tuesday to close a loophole that lets students use electronic nicotine delivery systems like vapes on school property. The legislation would also make it a crime under state law to sell these products to anyone under the age of 18. President Donald Trump is seeking a 10 percent cut to the U.S. Department of Education's budget in his fiscal 2020 budget proposal, which would cut the department's spending by \$7.1 billion down to \$64 billion starting in October.
- 7. Mr. Borrelli reported that the Freeport Area School District Foundation would make a presentation to the Board on the Foundation's activities over the past year, at the April 3, 2019, meeting.
- 8. Student school board members Patrick Keeley and Kyah Pastoria presented their reports on student activities. The student school board members introduced the 2019 DECA State Career Development Conference winners, John Zurisko and Kaitlyn Ritter.

- b. To approve the attached Addendum to a Lease Agreement with Freeport Baseball Association dated June 1, 2016, for the lease of a baseball field for the District's Athletics Programs, to extend the term of the Agreement for two (2) additional years (2020 and 2021) at a cost of \$7,775 per year.
